This document sets out the Benefits that are presently available to Members and Eligible People under the BMW Corporate Advantage Programme. Relevant definitions are set out at the end of this document. This document should be read in conjunction with the Terms and Conditions that constitute and apply to the BMW Corporate Advantage Programme.

Exclusive Pricing

1. Our approved dealers will offer you exclusive pricing when you want to purchase or lease any new BMW motor vehicle under this Programme. See your dealer for details.

After-sales Voucher

2. When you purchase or lease a Programme Vehicle you will receive a voucher to the value of \$1,000 (including GST) to use to purchase BMW Accessories and Lifestyle items at the dealership that sold or leased you the vehicle.
3. Voucher only for purchase of Accessories and Lifestyle items, excludes any labour and installation charges for any particular item purchased. Voucher is valid for 3 months from date of purchase or lease and can only be redeemed by the purchaser of the vehicle (Member or Eligible Person). Voucher cannot be transferred or assigned, nor can it be used with any other dealership offer that may be available. Voucher cannot be redeemed for cash, and must be redeemed in a single purchase. No "change" is given if total purchase is less than \$1,000.

4. BMW Financial Services New Zealand Limited offers exclusive and tailored financial services to assist you with your purchase or lease through our approved dealership network. Offers subject to BMW Financial Services Limited terms and conditions and subject to relevant lending eligibility criteria.

BMW Motor Vehicle Insurance benefits offered through Provident Insurance

5. Optional BMW Motor Vehicle Insurance is offered at the time you purchase or lease your new vehicle from our approved dealers. Insurance is provided through Provident Insurance Corporation Limited. Provident's terms and conditions will apply.
6. When you purchase or lease a Programme Vehicle, and should you be accepted for cover by Provident when you arrange insurance through them, then:
 - (a) **Annual product:** If you elect to purchase an annual BMW Motor Vehicle insurance policy, then BMW will meet your first year's premium on the Programme Vehicle to the maximum value of \$2,500 (inclusive of GST).
 - (b) **Multi-year product:** if you elect to purchase a multi year BMW Motor Vehicle Insurance policy then BMW will meet your first year's premium on the Programme Vehicle to the maximum value of \$2,500 (inclusive of GST) and we will guarantee the upfront amount of the premium you will have to pay to the insurer for years two and three of the cover.

Note, Provident's acceptance of cover, and its terms and conditions apply to these benefits.

7. You will receive special offers and promotions as they are made by BMW, and you will be given invitations to exclusive BMW events from time to time.

Definitions



9. In this document, unless the context otherwise requires:

Programme Vehicle means:

A new BMW motor vehicle that is purchased or leased from an approved BMW Dealer by a Member or and Eligible Person under the BMW Corporate Advantage Programme.
